

RESOLUTION NUMBER 3056

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF PERRIS, COUNTY OF RIVERSIDE, STATE OF CALIFORNIA, DESIGNATING REPRESENTATIVES TO THE JOINT POWERS COMMISSION OF THE JOINT POWERS AUTHORITY CREATED TO FORMULATE AND IMPLEMENT PLANS FOR THE USE AND REUSE OF MARCH AIR FORCE BASE AND RESCINDING RESOLUTION NUMBER 2914

WHEREAS, the Cities of Perris, Moreno Valley and Riverside ("Cities") and the County of Riverside ("County") having the authority and power to formulate and implement plans for the use and reuse of the March Air Force Base have met and discussed the present and future use and reuse of March Air Force Base; and

WHEREAS, the Cities and County have adopted a Joint Powers Agreement to form a Joint Powers Authority ("JPA") to collectively formulate and implement plans for the use and reuse of the March Air Force Base as a result of such meetings; and

WHEREAS, the Joint Powers Agreement authorizes the governing body of each member of the JPA to appoint by resolution, two of its elected officials as representatives to the Joint Powers Commission ("JPC"), the governing board of the JPA, for the term of the office held by the elected official in his or her respective jurisdiction, or sooner; and

WHEREAS, the City of Perris, as a member of the JPA is authorized in the Joint Powers Agreement to appoint two members to the JPC; and if it so chooses, it may appoint an alternate to the JPC from the Perris City Council; and

WHEREAS, the Mayor of the City of Perris annually appoints members of the City Council to the various Boards and Commissions.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Perris as follows:

Section 1. The City Council of the City of Perris appoints the following Legislators to the JPC of the March Air Force Base Joint Powers Authority:

Daryl Busch, Delegate
Raul (Mark) Yarbrough, Delegate
Alfred Landers, Alternate

Section 2. Resolution Number 2914 is hereby rescinded in its entirety.
