

RESOLUTION NUMBER 3159

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF PERRIS, COUNTY OF RIVERSIDE, STATE OF CALIFORNIA ORDERING THE ANNEXATION OF CERTAIN TERRITORY TO MAINTENANCE DISTRICT NUMBER 84-1 (CUP 02-0061, ASSESSOR PARCEL NUMBERS 305-030-024 AND 305-030-033)

WHEREAS, the City Council of the City of Perris, California, has previously formed a special maintenance district pursuant to the terms of the “Landscaping and Lighting Act of 1972”, being Division 15, Part 2 of the Streets and Highways Code of the State of California, said special maintenance district known and designated as MAINTENANCE DISTRICT NUMBER 84-1 (hereinafter referred to as the “Maintenance Districts”); and

WHEREAS, the provisions of Article 2 of Chapter 2 of the “Landscaping and Lighting Act of 1972”, authorize the annexation of addition territory to the Maintenance District; and

WHEREAS, at this time the City Council is desirous to take proceedings to annex the property described on Exhibit “A” attached hereto and incorporated herein by this reference to the Maintenance District; and

WHEREAS, all of the owners of property within the territory proposed to be annexed to the Maintenance Districts have filed with the City Clerk their written consent to the proposed annexation without notice and hearing or filing of an Engineer’s “Report”.

NOW, THEREFORE, BE IT RESOLVED, DETERMINED AND ORDERED by the City Council of the City of Perris as follows:

Section 1. That the above recitals are all true and correct.

Section 2. That this legislative body hereby orders the annexation to the property described in Exhibit “A” attached hereto to the Maintenance District.

Section 3. That all future proceedings of the Maintenance District, including the levy of all assessments shall be applicable to the territory annexed hereunder.
