## RESOLUTION NUMBER 2910

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF PERRIS, CALIFORNIA, ADOPTING THE OPTIONAL CITY-PAID BENEFITS PLAN RATE ADJUSTMENTS FOR CALENDAR YEAR 2002

**WHEREAS**, Government Code Section 22825.6 provides that a local agency contracting under the Public Employee's Medical contribution at an amount not less than the amount required under Section 22825 of the Act: and

WHEREAS, the City of Perris is a local agency contracting under the Act; and

**WHEREAS**, the City of Perris provides all full-time employees and retirees with City-paid medical insurance; and

**NOW, THEREFORE, BE IT RESOLVED** by the City Council of the City of Perris, California, as follows:

The City of Perris will provide funding for health insurance premiums for each full-time employee and retiree up to the median level of \$550.86 (employee with two or more dependents). The monthly median amount was calculated based upon the 2002 health insurance premiums below:

**Section 1**. A full-time employee may elect not to participate in the optional City-paid benefits plan if said employee has proof of medical coverage from another source.

**Section 2.** Upon written documentation to the Finance Director, such employee receives one-half of monthly median amount that would have been provided for the optional City-paid benefit, payable on the first payroll of each month, not to exceed \$275.00 (calendar year 2002).

**Section 3.** Should employee require future City-paid medical coverage, employee must wait until the next open enrollment period to elect coverage.
