A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF PERRIS, CALIFORNIA, PROVIDING CAR ALLOWANCES FOR DESIGNATED OFFICIAL AND EMPLOYEES AND RESCINDING RESOLUTION NUMBER 2552

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Perris, California, as follows:

Section 1. The duties of certain officials and employees require that they travel by motor vehicle. It is in the interest of the City that such officials and employees provide themselves with a motor vehicle for that purpose. Therefore, the following car allowances are authorized:

The persons holding the City offices or positions listed below shall be paid the car allowance below:

POSITION	CAR ALLOWANCE
Mayor and Council Members	\$400.00
City Clerk	\$400.00

As used herein, "car allowance" is a monthly payment of a flat sum to a City official or City employee as compensation for maintaining for use, and using, a motor vehicle for travel on City business. The sum payable shall be neither increased nor decreased due to the cost of the vehicle or its operation.

Nothing herein prohibits payment to a person of both a car allowance and reimbursement on a mileage basis of expenses for use of that person's motor vehicle for travel to a destination out of the Perris area. "Travel to a destination out of Perris area," as used herein, means a trip to a place that is either outside of San Bernardino and Riverside Counties, or more than forty (40) miles from City Hall, Civic Center, Perris. Any travel beyond the 40 miles radius (80 miles round trip) shall, in addition to the automobile expense, be reimbursed at the current mileage allowance provided to other City employees or officials. Reimbursement is limited to those miles in excess of the 40/80 mile limit.

Exception as stated herein, car allowances are not authorized.

Section 2. BE IT FURTHER RESOLVED that Resolution Number 2552 is hereby rescinded in its entirety.
