***A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF PERRIS, COUNTY OF RIVERSIDE, STATE OF CALIFORNIA, SUPPORTING THE MARCH AIR RESERVE BASE, AND THE MILITARY AND CIVILIAN PERSONNEL STATIONED AT MARCH FROM EVERY BRANCH OF THE SERVICE, (ACTIVE DUTY, RESERVE, OR GUARD) HAVE THE CITY OF PERRIS' UTMOST ADMIRATION AND SUPPORT, FOR CARRYING OUT THEIR VITAL MISSION TO DEFEND OUR GREAT NATION***
