## **RESOLUTION NUMBER 2860**

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF PERRIS, COUNTY OF RIVERSIDE, STATE OF CALIFORNIA APPROVING THE COMBINED REPORT FOR ABATEMENT OF WEEDS AND WASTE MATTER AND ASSESSING THE COST THEREOF PURSUANT TO CHAPTER 7.08 OF THE PERRIS MUNICIPAL CODE.

**WHEREAS,** weeds, grasses, dead trees, dead shrubs, or waste matter upon the parcels of the land in the City of Perris, which are described as Exhibit "A" attached hereto and made a part hereof, were determined to be public nuisances and were removed and abated pursuant to Chapter 7.08 of the Perris Municipal Code; and

**WHEREAS**, a combined written report of said abatement proceedings and account of the cost thereof, dated July 24, 2001, including an accurate itemized account of the cost of abating the nuisance on each separate parcel of land described in said Exhibit "A" was prepared as provided in accordance with Chapter 7.08 of the Perris Municipal Code and was filed in the office of the City Clerk on July 24, 2001; and

**WHEREAS**, said report and account were duly set for hearing by the City Council on July 31, 2001, and notice of hearing was given and the City Council heard said matter on said date; and

**WHEREAS**, it is found and determined by the City Council that the report and account are true and correct and should be approved.

**NOW, THEREFORE BE IT RESOLVED**, by the City Council of the City of Perris, California, that the above-mentioned report and nuisances on the parcel of land described in said Exhibit "A", as said costs are set forth in said Exhibit "A", are hereby charged and assessed as lien upon the respective parcel of land, as such parcel is shown on the most recent available equalized property assessment roll of the county of Riverside; and

**BE IT FURTHER RESOLVED**, that it is hereby found and determined by the City Council that the weeds, grasses, dead trees, dead shrubs, and waste matters so removed from the lot and parcel of the land described in said report and in said Exhibit "A" of this resolution, constitute a public nuisance upon said respective lot and parcel of land; and

BE IT FURTHER RESOLVED, that the City Clerk shall send a certified copy of this resolution, including Exhibit "A" to the Auditor-Controller of the County of Riverside.
