RESOLUTION NUMBER 2886

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF PERRIS, RIVERSIDE COUNTY, STATE OF CALIFORNIA, APPROVING THE COMBINED REPORT FOR ABATEMENT OF WEEDS AND WASTE MATTER AND ASSESSING THE COST THEREOF PURSUANT TO CHAPTER 7.08 OF THE PERRIS MUNICIPAL CODE

WHEREAS, weeds, grasses, dead trees, dead shrubs, or waste matter upon the parcels of the land in the City of Perris, which are described as Exhibit 'A' attached hereto and made a part hereof, were determined to be public nuisances and were removed and abated pursuant to Chapter 7.08 of the Perris Municipal Code; and

WHEREAS, a combined written report of said abatement proceedings and account of the cost thereof, dated October 30, 2001, including an accurate itemized account of the cost of abating the nuisance on each separate parcel of land described in said Exhibit 'A' was prepared as provided in accordance with Chapter 7.08 of the Perris Municipal Code and was filed in the office of the City Clerk on October 16, 2001; and

WHEREAS, said report and account were duly set for hearing by the City Council on October 30, 2001, and notice of hearing was given and the City Council heard said matter on said date; and

WHEREAS, no person appeared to protect or object to the report of the account, and it is found and determined by the City Council that the report and account are true and correct and should be approved.

NOW, THEREFORE, BE IT RESOLVED, by the City Council of the City of Perris that the above -mentioned report and nuisances on each of the parcels of land described in Exhibit "A", as said costs are set forth in said Exhibit "A", are hereby charged and assessed as liens upon the respective parcels of land, as such parcels are shown on the most recent available equalized property assessment roll of the County of Riverside; and

BE IT FURTHER RESOLVED that it is hereby found and determined by the city Council that the weeds, grasses, dead trees, dead shrubs, and waster matters so removed from the several lots and parcels of the land described in said report and in said Exhibit 'A' of this resolution, constitute a public nuisance upon said respective lots and parcels of land; and

BE IT FURTHER RESOLVED that the City Clerk shall send a certified copy of this resolution, including Exhibit "A" to the Auditor-Controller of the County of Riverside.
