RESOLUTION NUMBER 2893

RESOLUTION OF INTENTION OF THE CITY COUNCIL OF THE CITY OF PERRIS TO INCUR BONDED INDEBTEDNESS IN THE AMOUNT OF NOT TO EXCEED \$3,000,000 WITHIN PROPOSED COMMUNITY FACILITIES DISTRICT NO. 2001-3 (NORTH PERRIS PUBLIC SAFETY) OF THE CITY OF PERRIS.

WHEREAS, the City Council (the "Council") of the City of Perris, California (the "City") upon its own initiative as provided in Section 53318 of the Government Code of the State of California instituted proceedings to form Community Facilities District No. 2001-3 (North Perris Public Safety) of the City of Perris (the "Community Facilities District No. 2001-3" or the "District") pursuant to the Mello-Roos Community Facilities Act of 1982, commencing with Section 53311 of the Government Code of the State of California (the "Act"), as amended, pursuant to a resolution adopted by the Council on the date hereof to finance (1) fire protection and suppression services, and ambulance and paramedic services including all furnishings, equipment and supplies related thereto; (2) police protection services, including but not limited to criminal justice services, including all furnishings, equipment and supplies related thereto; (3) the purchase of any real or other tangible property with an estimated useful life of five years or longer relating to the Services, including furnishings and equipment related thereto (the "Facilities"); and (4) the incidental expenses to be incurred in connection with financing the Services and Facilities and forming and administering the District (the "Incidental Expenses"); and

WHEREAS, the Council estimates that the amount required to finance the Facilities and Incidental Expenses is \$3,000,000; and

WHEREAS, in order to finance the Facilities and Incidental Expenses, the Council intends to authorize the issuance of bonds in the maximum aggregate amount of \$3,000,000;and

WHEREAS, the repayment of the bonds is to be secured by special taxes levied in the District in accordance with Section 53328 of the Act, other than those properties exempted from taxation in the rate and method of apportionment for the District set forth in Exhibit "C" to Resolution No. 2892;

NOW, THEREFORE, the City Council of the City of Perris does hereby resolve, determine and order as follows:

Section 1. The above recitals are true and correct.

Section 2. It is necessary to incur bonded indebtedness within of the proposed boundaries of proposed Community Facilities District No. 2001-3 in an amount not to exceed \$3,000,000, to finance the costs of the Facilities and Incidental Expenses, as permitted by the Act.

Section 3. The bonds will be issued for the purpose of financing the costs of the Facilities and the Incidental Expenses, including, but not limited to, the funding of reserve funds for the bonds, the financing of costs associated with the issuance of the bonds and all other costs and expenses necessary to finance the Facilities which are permitted to be financed pursuant to the Act.

Section 4. It is the intent of the Council to authorize the sale of bonds in one or more series, in the maximum aggregate principal amount of not to exceed \$3,000,000 and at a maximum interest rate not in excess of 12 percent per annum or such rate not in excess of the maximum rate permitted by law at the time the bonds are issued. The term of the bonds of each series shall be determined pursuant to a resolution of the Council acting in its capacity as the legislative body of the District authorizing the issuance of the bonds of such series, but such term shall in no event exceed 40 years or such longer term as is then permitted by law.

Section 5. A public hearing (the "Hearing") on the proposed debt issue shall be held January 8, 2002 at 6:00 o'clock p.m. or as soon thereafter as practicable, at the chambers of the City Council of the City of Perris, 101 North "D" Street, Perris, California 92570.

Section 6. At the Hearing at the time and place set forth above, any interested persons, including all persons owning land or registered to vote within the proposed District, may appear and be heard at the Hearing.

Section 7. The City Clerk is hereby directed to publish a notice of the hearing (the "Notice") pursuant to Section 6061 of the Government Code in a newspaper of general circulation circulated within the proposed District. Such publication shall be completed at least seven (7) days prior to the date of the Hearing.
