

RESOLUTION NUMBER 2791

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF PERRIS, COUNTY OF RIVERSIDE, STATE OF CALIFORNIA, AMENDING RUBBISH COLLECTION CHARGES AS PERMITTED IN SECTION 7.16.050 (D) OF THE PERRIS MUNICIPAL CODE AND RESCINDING RESOLUTION NUMBER 2708

WHEREAS, the Consumer Price Index has increased by 2.3%; and

WHEREAS, said increase is necessary to defray these costs by increasing the rates and charges to the recipient of such services.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Perris as follows:

Section 1. Pursuant to 7.16.050 (D) of the Perris Municipal Code, the rates and charges of Chapter 7.16 are adjusted as follows:

“Section 7.16.050 Rubbish Collection and Disposal”

1. A monthly charge for rubbish collection, transfer, disposal and street sweeping services is hereby levied upon each occupied household and business establishment, in accordance with the following rates:

(a) Residential

(1) Single family residences, mobile homes, apartments, condominiums, townhomes, bungalow courts, and multiple residences per dwelling unit, using 100 gallon individual receptacles.

Monthly Rate: \$16.31

(2) Single family residences, mobile homes, apartments, condominiums, townhomes, bungalow courts, and multiple residences per dwelling unit, using 60 gallon individual receptacles.

Monthly Rate: \$12.77

(b) Commercial and Industrial

(1) Individual receptacles

Once per week pick up: \$16.81

(c) Commercial, Industrial, and Multiple Residences

(1) Two cubic yard container

1 x week	\$ 87.23
2 x week	\$159.51
3 x week	\$231.79
4 x week	\$304.07
5 x week	\$376.35
6 x week	\$448.63

(2) Three cubic yard container

1 x week	\$101.74
2 x week	\$186.76
3 x week	\$271.78
4 x week	\$356.80
5 x week	\$441.82
6 x week	\$526.84

(d) Other

(1) 10 to 40 cubic yard roll-off container

\$137.45 + MRF/landfill fees

(e) Street Sweeping Services

(1) Weekly Commercial, Arterial and Downtown Area

(2) Bi-weekly Residential Area

Additional Residential Rate: \$1.29 per residence

Additional Commercial Rate:

\$3.80 per pickup per month

These rates shall become effective July 1, 2000.

Section 2. Resolution Number 2708 is hereby rescinded.
