

RESOLUTION NUMBER 2819

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF PERRIS TO ASSES AND COLLECT AN IMPOUND RELEASE FEE OF \$75.00/\$150.00 FOR THE RELEASE OF ANY VEHICLE IMPOUNDED BY THE DEPARTMENT UNDER THE AUTHORITY OF CALIFORNIA VEHICLE CODE SECTION 22651 OR THE PERRIS MUNICIPAL CODE RESCINDING RESOLUTION NUMBER 1738

WHEREAS, members of the City of Perris Police Department are peace officers as defined at the California Penal Code Section 830 et seq. or are employees of the City engaged in directing traffic or enforcing parking regulations; and.

WHEREAS, California Vehicle Code Section 22651 and the Perris Municipal Code at Section 10.08.020 authorize the impounding of vehicles by a peace officer, as defined in California Penal Code Section 830 et seq. And salaried employees of cities engaged in directing traffic or enforcing parking regulations to impound vehicles; and

WHEREAS, at the present time it has been found and determined that a reasonable cost incurred by the Perris Police Department in exercising their authority to impound vehicles is \$75.00 (standard fee) and \$150.00 for 14602.6, 14607.6, 22651(h) (1), 22651(h) (2) and 22651 (p) ; and

WHEREAS, the imposition of a vehicle impound release fee may be accomplished by resolution pursuant to 22850.5 of the California Vehicle Code.

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF PERRIS, CALIFORNIA, DOES HEREBY RESOLVE, DELCARE, DETERMINE AS FOLLOWS:

SECTION 1. A standard impound release fee in the amount of \$75.00 and \$150.00 for 14602.6, 14607.6, 22551(h) (1), 22651(h) (2) and 22651 (p) is established and may thereafter be increased from time to time by resolution of the City Council and such fee shall be payable to the Perris Police Department prior to release of any duly impounded vehicle.
