A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF PERRIS, CALIFORNIA, COUNTY OF RIVERSIDE, STATE OF CALIFORNIA, AUTHORIZING THE DESTRUCTION OF CERTAIN CITY RECORDS (City Council Meeting Tapes)
