*A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF PERRIS, CALIFORNIA,  
COUNTY OF RIVERSIDE, STATE OF CALIFORNIA, AUTHORIZING THE  
DESTRUCTION OF CERTAIN CITY RECORDS  
(City Council Meeting Tapes)*

*WHEREAS*, Section 34090 of the California Government Code authorizes the destruction of City records upon approval of the legislative body of the City and the written consent of the City Attorney provided that said records do not fall within certain specified categories and are not less than two (2) years old; and

*WHEREAS*, Resolution Number 1235 of the City of Perris adopts a specific retention period of ninety (90) days from the date of creation of tape recordings of Regular Meetings, Regular Adjourned and Special Meetings of the City Council; and

*WHEREAS*, the City Clerk has requested authority and the City Attorney has approved the destruction of recordings of City Council Meetings described as follows:
