

RESOLUTION NUMBER 2708

A RESOLUTION OF THE CITY COUNCIL OF THE CITY
OF PERRIS AMENDING RUBBISH COLLECTION
CHARGES AS PERMITTED IN SECTION 7.16.050 (D) OF
THE PERRIS MUNICIPAL CODE AND RESCINDING
RESOLUTION NUMBER 2654

WHEREAS, the Consumer Price Index has increased by 1.4%; and

WHEREAS, said increase is necessary to defray these costs by increasing the rates and charges to the recipient of such services.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Perris, California, as follows:

Section 1. Pursuant to 7.16.050 (D) of the Perris Municipal Code, the rates and charges of Chapter 7.16 are adjusted as follows:

“Section 7.16.050 Rubbish Collection and Disposal”

1. A monthly charge for rubbish collection, transfer and disposal services is hereby levied upon each occupied household and business establishment, in accordance with the following rates:

(a) Residential

(1) Single family residences, mobile homes, apartments, condominiums, townhomes, bungalow courts, and multiple residences per dwelling unit, using 100 gallon individual receptacles.

Monthly Rate: \$15.96

(2) Single family residences, mobile homes, apartments, condominiums, townhomes, bungalow courts, and multiple residences per dwelling unit, using 60 gallon individual receptacles.

Monthly Rate: \$12.50

(b) Commercial and Industrial

(1) Individual receptacles

Once per week pick up: \$16.46

(c) Commercial, Industrial, and Multiple Residences

(1) Two cubic yard container

3 x week	\$226.81
4 x week	\$297.43
5 x week	\$368.05

(2) Three cubic yard container
