For purposes of disclosure, the Mayor, Members of the City Council and Planning Commission, the City Manager, the City Treasurer and the City Attorney are governed by the statutory conflict of interest provisions of Article 2 of the Chapter 7 of the Political Reform Act of 1974. (Government Code Section 87200 et seq).

Such written determination shall include a description of the consultant's duties and, based upon that description, a statement of the extent of disclosure requirements. The City Manager's determination is a public record and shall be retained for public inspection in the same manner and location as this Conflict of Interest Code.
